1.0 Welcome: Gene Goldwasser, President, welcomed everyone back from their summer vacations.

2.0 Minutes: The minutes of the June 20, 2018 meeting were distributed for all to review. The motion to approve them was made by Joseph Quinn and seconded by Vince Deland. It passed unanimously.

3.0 Treasurer's Report: Account balances as of September 1, 2018 were reported as follows:

5.0 Committee Reports:

5.1 Education:

Gene asked Mary to discuss her article in the NYSRSAS newsletter on the importance of homework. She mentioned that Long Beach School District is implementing a new policy eliminating traditional homework for elementary students. Instead students will be encouraged to spend more time reading at home and pursuing topics of personal interest and curiosity. The ensuing discussion included the following topics: homework helps build self-discipline and time management skills required for the demands of middle and high school, the quality and amount of homework, research regarding limited value of elementary homework as related to student success, and the importance of building parent/school partnerships in order to support student learning and achievement. We will return to this topic in December. It was suggested that members research articles to share at our next meeting.

5.3 Political Action:

Corrine expressed frustration in contacting the DNC and lack of support for reaching out to voters and working to engage more voter participation. Stu stressed the importance of the mid-term elections for state and congressional elections and supporting candidates that support public education and will protect health care, pension and retirement benefits.

Marty posed the following questions for consideration: How do we let the candidates know that we are endorsing them? What action do we take to support them?
